

Heartwarming success story of baby Rithran at Saveetha Hospital

Born with a congenital lung disease, Baby Rithran's life was transformed through exceptional care and treatment.

During her fifth-month antenatal scan conducted by the OBG department, Ms. Divyabharathi (Mother) received the diagnosis of her fetus's cystic lung disease. With consistent and efficient follow-up care, she delivered Baby Rithran under the expert guidance of Prof. Dr. Parimala Sudarshan and her team.

After birth, the neonatology team, led by Dr. J Kumudha, Dean, Saveetha Hospital,



ensured that the baby was well-resuscitated, hemodynamically stabilized, and exclusively breastfed. Throughout his first five months, Prof. Dr. Ezhilarasi, Head of Pediatrics, and her team provided continuous support and care, ensuring satisfactory weight gain

and overall well-being. At five months old, Baby Rithran underwent a successful thoracotomy and left upper lobectomy with minimal blood loss. This complex surgery was expertly performed by Prof. Dr. A. Ratna and Dr. Pradeep Karunagaran from the pediatric surgery

team. The procedure, conducted under single lung ventilation, was managed with exceptional intraoperative care and a smooth recovery, supported by Prof. Dr. A. Ratna and Dr. Pradeep Karunagaran from the anesthetic team.
